PURPOSE

Madam Speaker, this Ministerial Statement is intended to provide an update to this Honourable House and the people of Jamaica on the implementation of new arrangements to improve the legislative review process and the progress of legislation for the 2022/2023 Legislative Year.

BACKGROUND

Madam Speaker, the Ministry of Legal and Constitutional Affairs has been mandated to address the slow pace of legal reform in the public sector. Since its establishment in January (2022), the Ministry has been working assiduously to improve operational efficiency, speed, and the quality of legislation promulgated across government. The work is largely behind the scene and outside of the public glare.

Madam Speaker, the Ministry has adopted a projectised and collaborative approach to achieve results.

ISSUES

Madam Speaker, the legislative review process has been affected by delays, culminating in critical pieces of legislation neither being amended, repealed and replaced, nor developed and subsequently passed in a timely manner.

The situation is exacerbated by the paucity of human resources in some Ministries, coupled with the crafting of ambitious legislative targets prior to the start of each financial year. Some targets, which are encompassed in Strategic and Operational Plans, the annual Legislation Programme, and Throne Speeches, are not accorded priority and the concomitant dedication and focus by some entities.

Over the years, it has been observed that after the Throne Speech has been delivered, there is usually delay in some Ministries sending the necessary instructions. The Office of the Parliamentary

Counsel (OPC) is particularly affected by the current situation because it is at the end of the legislative production chain.

Madam Speaker, Cabinet Decision No. 43/20 dated 28 September 2020 identified the following issues affecting the legislative process:

- i. Inadequate or unclear drafting instructions from Ministries to the OPC, as well as the inordinate length of time taken for Bills to move between the key entities i.e. the Attorney General's (AGC), the OPC, and the Ministries during the drafting process;
- ii. Inadequate policy direction by Ministries to the AGC and the OPC;
- iii. The need for better communication amongst the key stakeholders;
- iv. Ministries were not properly addressing the concerns raised by the AGC in their comments on Cabinet Submissions and Bills;
- v. Ministries were tardy in responding to final draft Bills forwarded to them by the OPC;
- vi. The comments of the AGC on Legislative Cabinet Submissions were rarely sought and secured in keeping with the Guidelines for Cabinet Submissions;
- vii. There was need for a "filter" mechanism for quality control of Legislative Cabinet Submissions and Drafting Instructions;
- viii. Portfolio Ministers need to accept responsibility for the legislative aspects of their portfolios and the moving of their matters through the legislative process;

- ix. The need for greater prioritisation of legislation, guided by the Throne Speech and the Government's Priority Legislation Programme;
- x. Ministers and Permanent Secretaries should be more active in ensuring that legislative matters return to the OPC in a timely manner.

Madam Speaker, with a view to improving the process, my Ministry made a submission to the Cabinet in June (2022) proposing the introduction of a new system, and via Decision No. 20/22, dated 6 June 2022, the Cabinet granted approval for the following:

- (a) Establishment of a Legislative Team(s) in each Ministry, to include the relevant Policy Officer(s), the relevant Legal Officer(s), and the relevant Senior Officer(s) (at the level of Chief Technical Director, Principal Director or Senior Director) responsible for working closely with the relevant Policy and Legal Officers to provide oversight of the Ministry's Legislation Programme, as part of the work to strengthen inter-ministry collaboration to advance the Government's Legislative Agenda;
- (b) Collaboration between the Ministry of Legal and Constitutional Affairs and the Office of the Cabinet in supporting and monitoring the legislative work programme and implementing strategies to close gaps identified, using established and proven project management principles;
- (c) A projectised approach to law reform (in principle); and
- (d) Implementation of a public education programme on the Laws of Jamaica to augment awareness of, *inter alia*, (i) the legislative process; (ii) the role of all stakeholders in the process; (iii) the need for full compliance with the law; and, in particular, with the Charter of Fundamental Rights and Freedoms; and (iv) the Administrative/Public Law requirements for the exercise of statutory functions.

IMPLEMENTATION OF NEW ARRANGEMENTS

Madam Speaker, I am happy to report to this Honourable House and the people of Jamaica that progress has been made with respect to these proposals. All Ministries have established Legislative Teams and my Ministry has started working with them.

The inaugural meeting with the Legislative Teams was convened on September 9, 2022 (face-to-face) to enable the Ministry to, among other things, meet the respective officers and provide details on the new arrangements.

The MLCA has gone further to convene meetings with the Permanent Secretary and Legislative Team of each Ministry to:

- Review the progress of priority legislation encompassed in the 2022/2023
 Legislation Programme and the Throne Speech;
- Discuss strategies to accelerate the pace of reform for outstanding legislation; and
- Discuss legislative priorities for 2023/2024.

Meetings have been convened with the following Ministries to date:

- Office of the Prime Minister
- Ministry of Labour and Social Security
- Ministry of Education and Youth
- Ministry of Science, Energy and Technology

These meetings commenced in November (2022) and are scheduled to be completed by December (2022).

Madam Speaker, the Ministry now requires priority legislation to include subsidiary legislation (i.e. Regulations) and proposals to increase outdated fines and penalties. All Ministries were furnished with the pieces of legislation which contain fines and penalties which need to be reviewed and some have already prepared Cabinet Submissions.

Madam Speaker, a projectised approach has been introduced, which now requires all Ministries to work within settled timeframes. An agile, hand-holding approach has also been adopted by my Ministry to ensure that support to the Ministries is responsive and effective.

Each piece of legislation being amended or developed (if it is new) is being treated as a project and managed in accordance with established project management principles. The process involves the development of the project's scope, schedule, risks, and risk responses.

Legislative policy development has been identified as one of the major weaknesses. If the policy is not cogently expressed, this is likely to affect the quality of the related Cabinet Submission and Drafting Instructions to the Chief Parliamentary Counsel. With a view to closing this gap, my Ministry is seeking to introduce a training programme to build the capacity of officers in this area. It is projected that this training course will be implemented by the First Quarter of the 2023/2024 Financial Year.

PROGRESS OF LEGISLATION¹ - 2022/2023 LEGISLATIVE YEAR

Madam Speaker, I wish to now turn my attention to the progress of legislation contained in the 2022/2023 Legislation Programme and highlighted in the Governor General's Throne Speech delivered in February (2022).

Madam Speaker, a total of twenty-eight (28) specific items of legislation were identified in the Throne Speech, with seven (7) being enacted. These are:

- The Bank of Jamaica (Amendment) Bill
- The Natural Resources Conservation Authority (Cockpit Country Protected Area) Order
- The Road Traffic (Fixed Penalty Notice) Regulations
- The Firearms (Prohibition, Restriction and Regulation) Act
- The Dangerous Drugs (Cannabis Import, Export, Transit and Transhipment)
 Regulations
- The Road Traffic Regulations
- The Transport Authority (Amendment) Act

Of the remaining twenty-one (21) specific items, the Office of the Parliamentary Counsel (OPC) has drafted **nineteen (19)** instruments in relation thereto. These are as follows:

Madam Speaker, these items are at various stages of the legislative process, as reflected in a **Table** attached to this presentation.

Madam Speaker, there are a other matters which were mentioned in the Throne Speech which require legislative work, although no specific legislation was identified. Having regard to the foregoing, the OPC prepared the following legislation in support of those initiatives:

 Orders and resolutions to support the continuation or declaration (as the case may be) of Zones of Special Operations under the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) Act

- Proclamations for three (3) States of Public Emergency and the supporting regulations and continuance resolutions
- Orders under the Disaster Risk Management Act and the Public Health Act in respect of the COVID-19 pandemic
- The Food and Drugs (Coronavirus Vaccine) (Emergency Use Authorization) (Exemption) Regulations
- The Public Health (SARS COVID-19 Vaccination) Regulations
- The Tobacco Control Bill
- The Customs Tariff (Revision) (Amendment) Resolution

The OPC also prepared draft legislation in respect of a variety of other matters not mentioned in the Throne Speech. Over the period, April 1, 2022, to November 30, 2022, the OPC completed approximately **two hundred and thirty-three (233)** the matters referred to it for drafting or the provision of comments or advice. There are currently approximately **seventy-four (74)** items in the OPC awaiting completion. Drafting support is also provided through attendance at sittings of Parliament, including Joint Select Committees, and at the Legislation Committee of the Cabinet.

THE WAY FORWARD

Madam Speaker, moving forward, a realistic Legislation Programme must be crafted each year, having regard to the capacity of some Ministries, the heavy demands placed on the Ministry of Legal and Constitutional Affairs (i.e. request for comments by the Legal Reform Department, feedback on drafting instructions and the actual drafting of Bills by the OPC).

My Ministry pledges its commitment to working closely with all Ministries to accelerate the pace of reform. Already, we have begun to do periodic evaluation, ahead of the end of the current legislative year, to determine progress, weaknesses, and lessons learnt. Data gathered will facilitate adjustments prior to the commencement of the next legislative year.

PERIODIC UPDATES TO THE PARLIAMENT

Madam Speaker, following timely periodic updates to the Cabinet, the Ministry will also provide similar periodic updates to this Honourable House and the people of Jamaica on the progress of the performance of the legislative review process.

The status of those items is also provided in Table (below)
